WHO GOVERNS THE RELATIONSHIP BETWEEN THE CSD AND THE PARTICIPANT ?




HOW DOES THE CSD NOTIFY CHANGES ON CONDITIONS OF PARTICIPATION ?








ARE THE CASH AND SECURITIES MOVEMENTS SIMULTANEOUS ?







HOW ARE ELIGIBLE SECURITIES LODGED IN THE CSD SYSTEM ?




